背景 Background

《香港物流新銳大獎》是由香港特區政府在《現代物流發展行動綱領》倡議，並在香港物流發展局支持下由香港物流業界合作舉辦的嶄新物流業年度大獎，旨在表揚和鼓勵在創新、高端、智慧及綠色物流等領域有出色貢獻及展現卓越潛力的年青物流人才，並透過得獎者的成功故事，讓大眾了解現代物流業的發展新方向，並吸引更多年青人投身物流業，推動香港物流業的進一步發展。

The Hong Kong's NextGen Logistician Awards is a new annual award for the logistics industry advocated by the HKSAR Government in the Action Plan on Modern Logistics Development and organised through collaboration of various sectors of Hong Kong's logistics trade with the support of the Hong Kong Logistics Development Council (LOGSCOUNCIL). It aims to recognise and encourage young talents in the logistics industry who have made significant achievements and shown remarkable potential in innovative, high-end, smart and green logistics, and through the success stories of the award winners, to introduce the new development directions of modern logistics to the public, with a view to attracting more young people to join the industry to propel its continual growth.

獎項類別及參選資格

Award Categories and Eligibility Requirements

首屆《香港物流新銳大獎》共設以下三個獎項：

The inaugural edition of the Hong Kong's NextGen Logistician Awards has the following three award categories:

1. 物流新星獎 Emerging Talent Award

此獎項旨在表揚在物流業表現出卓越才能和潛力，並致力於進一步發展的練習生和年輕從業員。獲提名者應展示對所屬公司/機構或整個物流業所作出的優越和原創貢獻，尤其在創新、高端物流發展、智慧物流和綠色物流等領域的貢獻。

The award aims to recognise trainees and young practitioners who have demonstrated remarkable talent and potential for and commitment to further advancement in the logistics industry, as evidenced by their exemplary performance at work, as well as their excellent and original contributions to the companies / organisations they serve or to the logistics industry as a whole, especially in the areas of innovation, high-end logistics development, smart logistics and green logistics.

在遞交提名時，獲提名者須於物流業工作少於五年，其年齡亦須為35歲或以下。

Nominees must have joined the industry for no more than 5 years and be aged 35 or below at the time of submission of nominations.

2. 傑出專業獎 Young Professional Award

此獎項旨在表揚具有傑出領導潛力，並正擔任營運及中級管理層的年輕專業人士。獲提名者在所屬公司/機構所領導或推行的重大物流項目作出了重大貢獻，尤其在創新、高端物流發展、智慧物流和綠色物流等領域，並熱衷於物流業內深耕。

The award aims to recognise young professionals at operational to middle management levels who have strong leadership potential, led or made significant contributions instrumental to the delivery of major logistics-related initiatives, especially in the areas of innovation, high-end logistics development, smart logistics and green logistics, in the companies / organisations they serve; and shown strong commitment to the logistics industry.

在遞交提名時，獲提名者須於物流業工作至少五年，並正擔任營運及中級管理層職位，其年齡須為35歲或以下。

Nominees must have joined the industry for at least 5 years and are working at operational to middle management level, with their age being 35 or below at the time of submission of nominations.

3. 創新領導獎 Young Executive Award

此獎項旨在表揚具有卓越領導才能的年輕高級管理人員。除了在專業領域有的成就外，獲提名者對香港物流業發展作出了重大貢獻，尤其在創新、可持續發展、促進區域和國際合作及推廣等領域。

The award aims to recognise young executives at senior management levels who have demonstrated strong leadership and, apart from being accomplished in their professional capacities, have made substantial contributions to the development of Hong Kong's logistics industry, especially in the areas of innovation, sustainability, fostering of regional and international collaboration and promotion.

在遞交提名時，獲提名者須於物流業工作至少五年，並正擔任高級管理層職位，其年齡須為45歲或以下。

Nominees must have joined the industry for at least 5 years and are working at senior management level, with their age being 45 or below at the time of submission of nominations.

所有獲提名者必須為持有有效香港居民身份證的物流業現職從業員，並須由相關公司、專業團體或行業協會提名。

All nominees must be **incumbent practitioners** in the logistics industry who possess a **valid Hong Kong Identity Card**, and must be **nominated by companies, professional bodies or trade associations relevant to the logistics industry.**

每位獲提名者只可被提名參加一個獎項類別。倘秘書處就某獲提名者收到多於一份提名表格，首份呈交至秘書處的完整提名表格將被認定為該候選人的有效提名者。涉及該獲提名者的其他提名將不予考慮。

Any individual may be nominated for one award category only. If the Secretariat receives more than one nomination in respect of a given nominee, the first complete nomination form submitted to the Secretariat will be deemed the individual's valid nominator. Other nominations involving that nominee will not be considered.

每個獎項類別的得獎者數目不設上限或級別。獲提名者只要達到評審委員會設定的基準分數便可獲獎。

There will be no limit on the number of winners for or assignment of different award levels in each category. Nominees who meet the benchmark scores set by the Judging Panel will receive an award.

提名資格 Nomination Requirements

合資格提名者必須是以物流為其核心業務的香港註冊公司或機構，當中包括但不限於從事運輸、倉儲、配送、貨運代理和供應鏈管理的傳統物流公司，以及提供電子商務物流服務和綜合物流解決方案的現代物流公司。

Eligible nominators must be Hong Kong-registered companies or organisations with a core business focus on logistics. This includes but is not limited to traditional logistics companies specialising in transportation, warehousing and distribution, freight forwarding and supply chain management, as well as modern logistics companies offering e-commerce logistics services and integrated logistics solutions.

每間公司 / 機構就每個獎項類別只能提名一位獲提名者。

Each company / organisation is allowed to nominate no more than one individual for each award category.

評審準則及過程 Adjudication Criteria and Process

評審委員會由物流業界代表組成，成員包括香港物流發展局基建及推廣小組的成員以及其他業界翹楚。評審委員會會按以下五大準則作評審，並會設定基準分數以決定得獎者名單。

The Judging Panel, composed of representatives from the logistics industry, including members of the Subcommittee on Infrastructure and Promotion under the LOGSCOUNCIL and other industry leaders, will conduct adjudication based on the following five major criteria and will set benchmark scores to determine the list of awardees.

兩階段評審制 Two-stage Adjudication Process

第一階段：
根據提名表格及資料對獲提名者進行評分

1st Stage:
Nominees will be scored based on the written submissions and information

第二階段：
與在第一階段得分最高的獲提名者進行面試以選出得獎者

2nd Stage:
Highest-scorers from the 1st stage will be shortlisted for subsequent interview for selection of winners

秘書處會於第一階段評審結束後，以書面通知入圍之獲提名者有關後續面試的安排。入圍之獲提名者必須出席後續面試方能取得獲獎資格。

After the completion of the 1st stage of adjudication, the Secretariat will notify shortlisted nominees in writing about the arrangements for the subsequent interviews. Shortlisted nominees must attend the interviews to qualify for the award.

頒獎典禮 Award Presentation Ceremony

頒獎典禮將於2024年11月19日舉行，有關資料將於稍後提供予獲提名者。秘書處或會向得獎者索取進一步資料作宣傳之用。

The Award Presentation Ceremony will be held on 19 November 2024. Relevant information will be provided to the nominees in due course. The Secretariat may request further information from the winners for publicity purposes.

得獎者必須親身出席頒獎典禮以領受獎項。如未能親身出席，得獎者將被視作自動放棄獲獎資格。得獎者不可授權代領或補領獎項。

The winner must attend the Award Presentation Ceremony in person to be eligible to receive the award. The winner(s) shall be disqualified if he / she is absent from the ceremony. Any authorised third-party is not allowed to receive the award. Requests for receiving the award in occasions other than the ceremony will not be entertained.

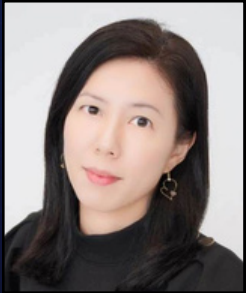

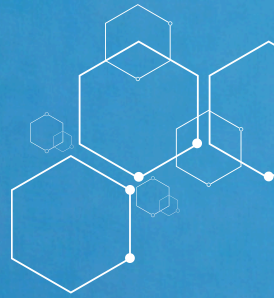
